To the Village Board of the Village of Butler, Wisconsin:

I hereby apply for a license to serve Fermented Malt Beverages and Intoxicating Liquors, subject to the limitations imposed by Sections 125.17 and 125.68(2) of the Wisconsin Statutes and all acts amendatory thereof and supplementary thereto, and hereby agree to comply with all laws, resolutions, ordinances, and regulations (Federal, State, or Local) affecting the sale of such beverages and liquors if a license be granted to me, from date hereto to June 30, 20____, inclusive (unless sooner revoked) –or- temporary license _____.

If you have not completed a Responsible Beverage Training Course or been licensed within the past two (2) years, you may apply for a Provisional License if you are enrolled in a training course and have also made application for a Regular License. (Proof of enrollment is required.) There is a minimum 96 hour (4 day) waiting period before a Provisional License can be issued.

If you currently hold a valid operator's license issued in the State of Wisconsin, you may file a certified copy of your operator's license with the Village of Butler and receive a Regular Operator's License upon payment of a \$40 fee. Unless revoked under Section 125.17(5)(e) Wisconsin Statutes, such license is valid either for one (1) year from the date the license becomes valid in the Village of Butler or for the period remaining on the license under the ordinances of the issuing municipality, whichever is shorter.
