PROPERTY TAX INFORMATION AND PAYMENT DATES

HOW AND WHERE CAN I MAKE A PAYMENT?

Village Hall is open from 8:00 am to 4:00 pm, Monday through Friday. Village Hall will be **CLOSED** on;

- December 24
- December 25
- January 1

The Village has a lock box located on the west side off Village Hall for property owners who wish to pay their property tax bill after business hours. Tax payments received in the lock box before midnight on December 31st are processed as paid in 2019. Tax payments received after midnight will reflect payment in 2020.

All refunds will be mailed within ten days of receipt of payment. No receipts will be sent for payments received in the mail unless a self-addressed stamped envelope is provided.

ELECTRONIC TAX PAYMENTS

The Village of Butler and Waukesha County have partnered with Point and Pay to accept electronic payments for property taxes using the Village website, www.butlerwi.gov.

Making an online tax payment:

Payments can be made either **by using an approved credit card or by electronic check.**



User Fees Do Apply:

User fees will apply and differ per payment type. Please read below for more information.

*For e-checks, the user is responsible for entering correct routing number and account information. Failure to supply accurate bank information will be considered to be a non-payment.

WHEN ARE TAX PAYMENTS DUE?

If you are paying your taxes in full, payment must be received on or before January 31, 2020. Installment payments of taxes are due as follows:

- 1st Installment due by January 31, 2020
- Final Installment due by July 31, 2020*



WHERE DO MY PROPERTY TAXES GO?

The Village collects taxes for four other taxing jurisdictions that establish their own budgets and levies. Below is an example of the allocation of property taxes to each taxing jurisdiction for a home with an assessed value of \$163,000.



WHAT DO I PAY FOR VILLAGE SERVICES?

Though the Village collects all the taxes, we only keep a small portion. The portion of property taxes the Village keeps are used to provide police and fire protection, refuse and recycling collection, snow and ice control, leaf and yard waste collection, routine street maintenance, sidewalk and alley maintenance, street and traffic lighting, library services, park facilities and maintenance, building inspection, election administration, and other miscellaneous Village services. A homeowner of a home assessed at \$163,000 would pay approximately \$1,318.67 in property taxes for Village provided services. The total monthly cost for Village services on a \$163,000 home is approximately \$108.79 allocated to departments as follows:
